RECITALS

WHEREAS, Section 720.317 of the Homeowners Association Act (the "Electronic Voting Statute"), provides that an association may conduct elections and other owner votes through an Internet-based online voting system if an owner consents, in writing, to online voting and if various requirements are met; and

WHEREAS, at the September 7, 2019 regular meeting of the Board of Directors, the Board adopted a Resolution in compliance with the Electronic Voting Statute to implement electronic or "online" voting for the membership;

WHEREAS, the Board of Directors has since approved a vendor to provide the online voting platform for those members of Mallory Creek who wish to vote online, which vendor may be changed in the future by the Board of Directors at its discretion.

WHEREAS, the Board of Directors now wishes to approve the forms for Members to utilize to express their written consent to voting online, as well as to provide members with a form to utilize if they desire to revoke their consent to online voting in the future.

WHEREAS, the Board of Directors also wishes to modify the time frames previously established for a Member to consent to voting online and revoke such consent.

NOW THEREFORE, it is resolved as follows:

- 1. The "Consent to Electronic Voting" and "Revocation of Consent to Electronic Voting" forms attached to this Resolution as **Exhibits "A" and "B"**, respectively, are hereby approved as the forms to be used by the membership to consent and revoke such consent to online voting.
- 2. Members who desire to vote online must complete and sign the Consent to Electronic Voting form and on file to the Association no later than 30 days prior to meeting at which the vote will take place.

3. Members who have chosen online voting may subsequently opt out of online voting by completing and signing the Revocation of Consent to Electronic Voting form and on file with the Association no later than 30 days prior to meeting at which the vote will take place.

BE IT FURTHER RESOLVED that this Resolution shall be recorded in the official records of Palm Beach County, Florida.
